

Reservation Policies and Information

What's Included:

Your Conference Registration provides you to admission to all speaker events , all seminars and meetings, the Hospitality Room with coffee, water and snacks, the Friday Night Welcome Reception, Saturday Night entertainment, and the Sunday Morning Spiritual Breakfast.

Extra Events

The Saturday Night Buffet is held outside in a beautiful setting on the Seven Columns Terrace overlooking the Banderas Bay. There is an extra charge for this dinner.

Companion Tickets for the Saturday Night Buffet and Entertainment are available only to guests of attendees who have paid the full registration and regular Buffet fees. Only one Companion Ticket is available to each attendee and the total number of Companion Tickets is limited. Companion Ticket Holders are NOT allowed to attend any other functions unless they pay for a full registration.

The Sober Cruise motors from the nearby Cruise Ship Marina across the beautiful Banderas Bay to a rustic Mexican village. We frequently see whales, dolphins, rays and other wildlife during the cruise. It is held on the Monday following the Conference. There is an extra charge for the cruise as well as a small port entrance fee (not included in your cruise ticket price).

Travel Arrangements:

The volunteer committee members who make these arrangements are not travel agents. We do not arrange air transportation or accommodations other than with the convention hotel.

The Hotel:

We do not have any affiliation with the nH Krystal Hotel. The hotel provides rooms, meeting spaces and meals for our functions in exchange for contracted fees and room rentals of our attendees, speakers and guests.

To ensure your room request has been correctly reserved by the hotel, we are collecting from you and depositing with the hotel a \$150.00 deposit (\$350 for a Family Suite) against the minimum 2 night stay (January 29 and 30, 2010).

When you check in, the hotel will ask for you to sign a credit card voucher as a guarantee of payment. Upon check out you will pay for the additional room nights you reserved (plus any required taxes, and any incidental expenses incurred during your stay). Please check your final bill carefully to be sure you receive credit for your deposit.

Room Rates are guaranteed and quoted by the hotel in \$US. The rates quoted are per room per night for one or two people to use the room. There is an additional charge of \$35 per person per night for additional people to stay in the room

The rates quoted do NOT include the required 18% for taxes and gratuities. These will be added to your final bill.

The maximum number of people that we will reserve per guest room is four (4). Exceptions have been made in cases where families with children have attended. The minimum stay is Friday and Saturday nights (January 29 and 30). The Casitas (limited number) will accommodate a maximum of 12 people.

The hotel has made these special rates available (3) days before and (3) days after the conference - subject to availability and based on the minimum required stay of Friday and Saturday nights (Jan 29 & 30). Check-In Time is 3:00 PM : Check-Out Time is Noon.

We have taken all possible precautions to ensure that rooms are booked as requested on your registration/reservation form. Until we receive confirmation from the hotel reservations may be subject to change. We will confirm with you IF YOU GIVE US AN EMAIL ADDRESS.

Conference registration capacity, Saturday buffet, Sober Cruise and hotel rooms are all limited. To insure you get all your requests met, **register early!**

Cancellation Policy

No Hotel deposits can be refunded after December 30th. However hotel deposits are transferable as long as the transfer does not cause a decrease in the total number of room nights booked with the hotel.

Conference registration, Banquet and sober cruise is refundable before January 22nd.

Refunds will be made through Pay pal or via check from our US account. Refunds will be issued within 60days of request.
